## LOCAL FLAVOR ANNUAL READER'S POLL SWEEPSTAKES

## **OFFICIAL RULES**

## 1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. SUBJECT TO APPLICABLE FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED.

2. <u>Eligibility</u>. The Local Flavor Annual Reader's Poll Sweepstakes (the "Sweepstakes") is open to legal United States residents residing in Pennsylvania who are eighteen (18) years or older at the time of entry. Employees, officers, and directors of Local Flavor ("Sponsor"), Clipper Magazine LLC, and each of their respective parents, subsidiaries, and affiliated companies, and any advertising or promotional agencies involved with the Sweepstakes (collectively, the "Sweepstakes Entities"), and the immediate family members of, and any persons domiciled with, any such employees or contractors, are not eligible to enter or to win.

Maximum one (1) entry per person. Multiple entrants are not permitted to share the same email address. Your computer must accept cookies, or any successor or similar technology, which may be used for the purpose of entry tracking. Ad blocking software on your computer needs to be disabled so that it doesn't interfere with processing your entry. Entrants must complete all questions as directed on the entry form to be eligible for the Sweepstakes. All entries become property of Sponsor and none will be returned. By entering, you agree to the terms of these Official Rules and to receive emails from Sponsor or those directed by Sponsor. You can opt-out of the receipt of such emails by following the directions in any email received from Sponsor.

The authorized account holder of the e-mail address submitted at time of entry will be considered the entrant. An "authorized account holder" shall mean the natural person assigned to such e-mail account by the Internet access provider, online service provider, or other organization responsible for assigning e-mail addresses for the domain associated with such e-mail account. A potential winner may be requested to provide proof that he or she is the authorized account holder of the e-mail address associated with a winning entry. In the event of a dispute, any online entries will be deemed to have been submitted by the owner of the ISP account from which they were sent, as long as such person is otherwise eligible and in compliance with these Official Rules. For these purposes, an ISP account holder shall mean the natural person assigned to such ISP account by the Internet access provider, online service provider or other organization responsible for assigning ISP addresses for the domain associated with such ISP account.

4. <u>Winner Selection; Prize; Odds</u>. On or about Tuesday, August 1, 2017 one (1) potential winner will be selected in a random drawing from among all eligible entries received. Sponsor reserves the right in its sole discretion to disgualify any individual who is found to be tampering with the entry process or the operation of the Sweepstakes or the Website, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law.
