

LOCALFLAVOR.COM CRAVE THE SAVE SWEEPSTAKES

OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. SUBJECT TO APPLICABLE FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED.**

2. **Eligibility.** The LocalFlavor.com Crave The Save Sweepstakes (the "Sweepstakes") is open to legal United States residents residing in the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older at the time of entry. Employees, officers, and directors of LocalFlavor.com ("Sponsor"), Clipper Magazine, LLC, Local Flavor Magazine, Great Deals Magazine, Get1Free Coupon Magazine, Mint Magazine, Market Magazine and REACH Magazine and any advertising or promotional agencies involved with the Sweepstakes (collectively, the "Sweepstakes and their respective parents, subsidiaries, and affiliated companies, and any advertising or promotional agencies involved with the Sweepstakes (collectively, the "Sweepstakes Entities"), and the immediate family members of, and any persons domiciled with, any such employees, are not eligible to enter or to win.

During the Sweepstakes Period, enter by scanning the QR code on the print advertisement or go to <https://www.localflavor.com/sweepstakes/crave-the-save> ("Website"), follow the on-screen instructions to register as a user of LocalFlavor.com (if you are not already registered), complete any additional registration information on the entry form, and follow all posted instructions to submit your entry and receive one (1) entry into the random drawing. Becoming a LocalFlavor.com member is free.

Maximum one (1) entry per person/email address per day during the Sweepstakes Period. For purposes of these Official Rules, a 'day' is defined as any twenty-four (24) hour period during the Sweepstakes Period beginning at 12:01 am ET and ending at 11:59 pm ET. Multiple entrants are not permitted to share the same email address of LocalFlavor.com account. Your computer must accept cookies, or any successor or similar technology, which may be used for the purpose of entry tracking. Ad blocking software on your computer needs to be disabled so that it doesn't interfere with processing your entry. Entrants must complete all questions as directed on the entry form to be eligible for the Sweepstakes. All entries become property of Sponsor and none will be returned. By entering, you agree to the terms of these Official Rules and to receive emails from Sponsor or those directed by Sponsor. You can opt-out of the receipt of such emails by following the directions in any email received from Sponsor.

The authorized account holder of the email address submitted at time of entry will be considered the entrant, as long as such person is otherwise eligible to participate in the Sweepstakes in accordance with these Official Rules. An "authorized account holder" shall mean the natural person assigned to such email account by the Internet access provider, online service provider, or other organization responsible for assigning e-mail addresses for the domain associated with such email account. A potential winner may be requested to provide proof that he or she is the authorized account holder of the email address associated with a winning entry. In the event of a dispute, any online entries will be deemed to have been submitted by the owner of the ISP account from which they were sent, as long as such person is otherwise eligible and in compliance with these Official Rules. For these purposes, an ISP account holder shall mean the natural person assigned to such ISP account by the Internet access provider, online service provider or other organization responsible for assigning ISP addresses for the domain associated with such ISP account.

4. **Winner Selection; Prize; Odds.** On or about Friday, April 5, 2024, five (5) potential winners will be selected in a random drawing from among all eligible entries received. Five (5) Prizes are available; each consisting of a check for \$500 to be issued to the prize winner ("Prize"). Odds of winning depend on the total number of eligible entries received for the Sweepstakes. Total approximate retail value ("ARV") is

\$2,500. All federal, state and local taxes on prize are the sole responsibility of the prize winner. Limit one (1) prize per person in the Sweepstakes.

5. **Winner Notification and Acceptance**. The potential winner will be notified on or about Friday April 5, 2024 at the email address provided on potential winner's entry form. Sponsor shall have no liability for any potential winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within forty-eight (48) hours of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Sweepstakes or the Website(s), to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. No mechanically reproduced, illegible, incomplete, forged, software-generated or other automated multiple entries will be accepted. Inclusion in such drawing shall be each entrant's sole and exclusive remedy

under such circumstances. These Official Rules cannot be modified or amended in any way except in a written document issued by a duly authorized representative of Sponsor. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Any questions regarding the number of entries or votes submitted by the owner of an ISP account shall be determined by Sponsor in its sole discretion.
