## LOCALFLAVOR.COM SEASON OF SAVINGS SWEEPSTAKES

## **OFFICIAL RULES**

- 1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. SUBJECT TO APPLICABLE FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED.
- 2. <u>Eligibility</u>. The LocalFlavor.com Season of Saving Sweepstakes (the "Sweepstakes") is open to legal United States residents residing in the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older at the time of entry. For purposes of these Official Rules, a 'day' is defined as any twenty-four (24) hour period during the Sweepstakes Period beginning at 12:01 am ET and ending at 11:59 pm ET. Multiple entrants are not permitted to share the same email address of LocalFlavor.com account. Your computer must accept cookies, or any successor or similar technology, which may be used for the purpose of entry tracking. Ad blocking software on your computer needs to be disabled so that it doesn't interfere with processing your entry. Entrants must complete all questions as directed on the entry form to be eligible for the Sweepstakes. All entries become property of Sponsor and none will be returned. The authorized account holder of the email address submitted at time of entry will be considered the entrant, as long as such person is otherwise eligible to participate in the Sweepstakes in accordance with these Official Rules. An "authorized account holder" shall mean the natural person assigned to such email account by the Internet access provider, online service provider, or other organization responsible for assigning e-mail addresses for the domain associated with such email account. A potential winner may be requested to provide proof that he or she is the authorized account holder of the email address associated with a winning entry. In the event of a dispute, any online entries will be deemed to have been submitted by the owner of the ISP account from which they were sent, as long as such person is otherwise eligible and in compliance with these Official Rules. For these purposes, an ISP account holder shall mean the natural person assigned to such ISP account by the Internet access provider, online service provider or other organization responsible for assigning ISP addresses for the domain associated with such ISP account.

4. <u>Winner Selection; Prize; Odds</u>. On or about Tuesday, January 2, 2024, ten (10) potential winners will be selected in a random drawing from among all eligible entries received. Ten (10) Prizes are available; each consisting of a check for \$500 to be issued to the prize winner ("Prize"). Odds of winning depend on the total number of eligible entries received for the Sweepstakes. Total approximate retail
